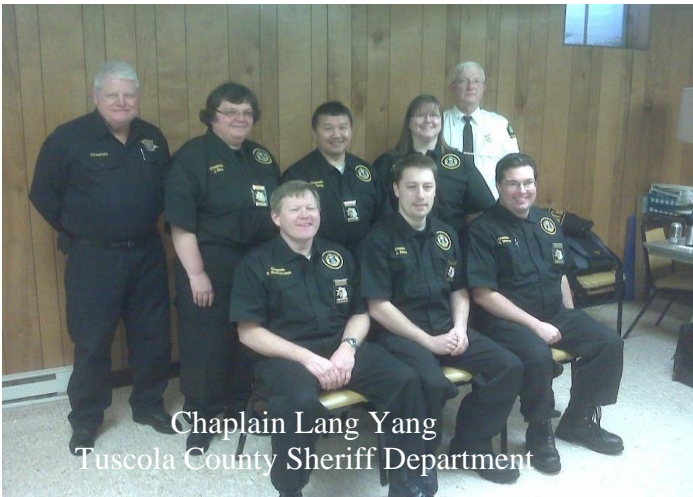




Rev. Dr. Lang Yang was born in Xiengkhouang, Laos. He came to the United States in 1979, when he was 11 years old. He had a Juris Doctor Degree in Law (J.D.), Doctor of Ministry Degree (D. Min), Master of Divinity Chaplaincy (M. Div), Bachelor of Science Degree in Criminal Justice, an Associate in Applied Science Degree in Criminal Justice, and Associate Arts Degree in General Education. In 1996, they moved from North Carolina to Richville, Michigan, and became St. Michael's Lutheran Church members. Dr. Yang has served as President of Txakee Yang, Inc., Loss Prevention Investigator, First Hmong Law Enforcement Officer in North Carolina, Store Manager, English/Hmong Interpreter Language Specialist, and ordained through The Lutheran Church – Missouri Synod (LCMS). Dr. Yang had served as Associate Pastor and Minister to the Hmong members at St. Michael's (2004-2022), Our Savior Lutheran Church and School in Lansing, and Hmong Mission Outreach with the Michigan District LCMS beginning in 2004. Dr. Yang graduated

on October 22, 2008, from Concordia Seminary St. Louis through the Ethnic Immigrant Institute of Theology (EIIT) alternate route to ordination. Dr. Yang has served the North America Hmong Ministry as President Hmong Mission Society since 2012. He served three terms (6 years) as President of the LCMS Hmong Ministry Conference, Alumni Council for Concordia Seminary St. Louis, Committee of the LCMS Hmong Hymnal Project, and served as Counselor for the Hmong Lutheran Women Mission LCMS. He also helps with the mission work in Thailand through the Hmong International Mission by teaching pastoral candidates, students, Hmong Ministry leaders, and outreach to the Hmong people. Dr. Yang is the first Hmong in the world appointed as an Officer to serve as Chaplain (CPT) with the United States Army Reserve. He is certified to teach Strong Bond – Speed of Trust for Soldier, Family, and Marriage. He also teaches Ask, Care, Escort – Suicide Intervention (ACE-SI). Dr. Yang currently serves as the volunteer Great Lake Region Deputy Chaplain for the Civil Air Patrol – United States Air Force Auxiliary. He is a qualified Mission Chaplain, Ground Team Member (GTM3), Urban Direction Finding (UDF), and Mission Staff Assistant. He also serves as Chaplain for the Tuscola County Sheriff Department Chaplain Corps, Denmark Township, and interprets Hmong/English for the Secretary of State in Michigan. He is a certified instructor teaching First Aid/CPR/AED for the American Red Cross. A Certified Church Planter Trainer with Church Dynamic Planter International (CDPI) qualified him to train people in Church Planting Church and Church Planting Essential. He is a Certified Instructor for the International Conference of Police Chaplain (ICPC). He can teach the courses anywhere in the world.

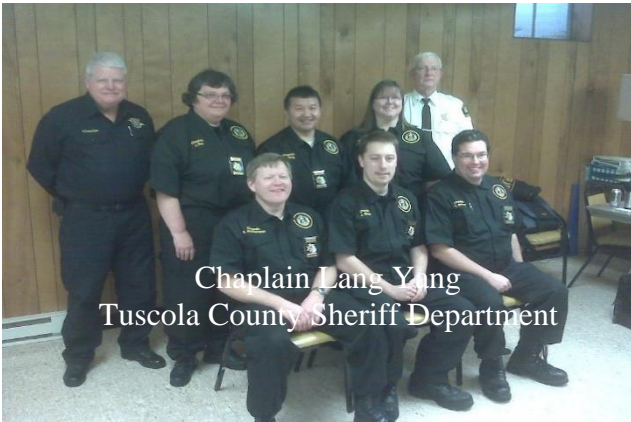
